- \* Purchaser shall have the puppy examined by a licensed veterinarian within 48 hours from the time of sale. If such exam reveals any life-threatening health disorder that causes the death of the puppy, we will replace the puppy, provided the puppy is necropsy and findings and results of such exam are in writing and sworn to by the vet and the vet's report is delivered to us within 24 hours of the exam. EAR MITES, WORMS, KENNEL COUGH AND COCCIDIA OR GIARDIA ARE NOT SERIOUS PROBLEMS IF TREATED AND ARE NOT COVERED AS REASONS FOR ANY REPLACEMENT.
- \* There has been no neglect or abuse of the puppy by the Purchaser that causes or aggravates any life-threatening illness or disorder resulting in the death of the puppy.
- \* We shall have the right to have the puppy examined by a licensed veterinarian, at our expense, as soon as practicable upon

receipt of the report from Purchaser's vet, prior to making any replacement or adjustment. If we elect to have the puppy examined by our vet and the findings of our vet's exam agree substantially with those made by the Purchaser's vet, we vill

replace the puppy at no extra charge, and

- \* ANY REPLACEMENT SHALL BE OUR CHOICE FROM STOCK ON HAND OR FROM EXPECTED LITTERS. Cash refunds may be considered at the seller's sole discretion.
- B. Subject to the foregoing, we will not be responsible for any veterinarian expenses or for any health care for the puppy or for grooming, food, landlord's disapproval, allergies to people, or disputes over ownership of the puppy.
- C. Because of the danger of exposure to outside diseases, we reserve the right to refuse the return of any puppy in order to protect the health of the entire Kennel. Any puppy that is in need of rehomeing must be brought back to us; there will be

no compensation for this service.
